SOCIAL MEMBERSHIP—IMPORTANT INFORMATION
(PLEASE KEEP THIS PAPER FOR YOUR RECORDS)

Social Membership is a family membership and includes a spouse (or significant other residing in the same household) as well as any dependent living in the member's home and who is either (1) under the age of 21, or (2) is a full time student under the age of 24 enrolled in 12 or more college credit hours each term.

PRIVILEGES/RULES:

POOL

Pool hours are 6:30am-7pm, weather permitting.

Any child under the age of 15 must be supervised at all times by an adult 18 and over.

Swimsuits are not allowed in the Clubhouse or The Crooked Tree Grille but are allowed on the Grille deck with appropriate swimsuit cover (towel, t shirt, swimsuit cover-up).

You may bring non-alcoholic beverages and food into the Pool area. All food must be in non-breakable containers and member is solely responsible for clean-up.

Members may bring guests to the pool for \$2 plus tax per day. This privilege is afforded on the honor system—please notify the Pro Shop desk attendant when you bring guests so your account may be charged accordingly.

There is no life guard on duty at the pool.

Pets are not allowed.

Popping towels, pushing, dunking of others, running, and general 'horseplay' are prohibited in the pool area.

GOLF

Social Members may use the Driving Range, Practice Greens, and may play golf at the Daily Guest rate. RBCC Club Carts may only be rented to and driven by those individuals aged 16 or over possessing a valid driver's license or by those possessing a learner's permit with an accompanying licensed adult.

FISHING

Fishing in RBCC golf course lakes is open to Social Members (including spouse and children), and their accompanied guests. Fishing must not interfere with or disrupt golfers.

CLUB CHARGE ACCOUNT, MINIMUM COMMITMENT, BILLING

Social Members have a Club Charge Account set up for them. This account must be used for all golf purchases and may be used for all Clubhouse/Crooked Tree Grille purchases. Purchases made in Clubhouse or Grille include a 15% service fee and a 6.5% tax regardless of the method of payment (Club Charge, credit card, cash).

Minimum Social Membership runs for 1 full month starting on the 1st of each month. You may join mid-month in which case you will be billed for the pro-rated remainder of the partial month plus the next complete month (e.g. if you sign up on the 13th, your minimum time commitment as a Social Member will start on the 13th through the end of that month plus the entire month following).

Membership dues are billed in advance on the 1st of each month, and late charges will apply after the 20th. Members must pay with check, cash, ACH automatic checking account withdrawal, or credit/debit card. Credit/debit cards incur an additional 3% service fee.

To cancel a membership, two week notice must be submitted in writing to the Accounts Manager at admin@rockybayoucc.com. No cancellation fees apply. No partial membership dues will be refunded.

IMPORTANT NOTE

There is no severe weather warning system on the Rocky Bayou Country Club grounds. Accordingly, all swimmers, golfers, and guests must take personal responsibility for their actions during inclement weather. We encourage all members and guests to be mindful of severe weather and to exercise due caution when lightning is observed to be in the area.

4. Membership may be started on 1st or 15th of month only.
5. **If not planning on renewing after your free month is expired, you must notify the Accounts Manager in writing. Free memberships starting on the 1st must submit notice by the 15th; free memberships starting on the 15th, must submit notice by the 29th. Failure to do so will incur an automatic charge for the following month.**
